## President's Message

My fellow IITK alum,

The IITK Foundation board's term is for three years and as we complete our first term I once again welcome the broader IITK alumni community with this third Annual Report to update you on our activities, accomplishments, and finances.

About three years ago, a group of veteran IITK Foundation leaders – Deepak Bhagat, Abhay Bhushan, and Ram Misra – passed on the baton to lead the Foundation to, shall I say, a slightly younger team headed by me as the president along with my esteemed team members: Vinod Baya (CFO), Jai Rawat (VP Fundraising), Atul Mathur (VP Events), Surbhi Kaul (VP Marketing), and Ratan Bajpai (Secretary). Through our collective volunteering effort and with the support from IITKDF team led by Kapil Kaul at Kanpur we have achieved several accomplishments:

- Launching of IITK Foundation website <https://iitkfoundation.org>
- Publishing of annual newsletter to keep the broader alumni group updated on latest activities and finances
- Facilitating organization of the annual Karvaan event (more on this later)
- Running multiple fundraising campaigns for a number of causes (Covid related help, Laptop drive, various endowment chairs, etc.)
- Last but not the least, I am happy to report that through the entire first term, the team has helped raise over \$24,000,000 (twenty-four million) USD. I am very grateful to the generosity of the donors across the continent and would like to express my deepest thanks to my extended team at IITK Foundation as well as to Kapil Kaul and his entire support staff at IITKDF.

Maintaining continuity in leadership is quite important to sustain momentum in any organization. To that end, I am happy to report that a number of current IITK Foundation leaders (Vinod Baya, Jai Rawat, Ratan Bajpai, and myself) will continue to lead the Foundation in the next term. We welcome Divya Yerraguntla as a new board member to lead the charter of Outbound Marketing. We have also added a layer of officers to help with the execution of the Foundation. We welcome Sheo Jha (VP Legal), Sumeet Singal (VP Finances), and Vipin Agarwal (VP Fundraising) as new officers of the organization.

We bid farewell to Prof. Abhay Karandikar who has recently left the IITK director role and taken a position with Govt. of India as the top leader of the Department of Science and Technology. Prof. Karandikar had been a strong advocate of IIT Kanpur and significantly transformed the institute-alumni relationship during his tenure. We are deeply grateful for his service and wish him all the best in his new journey. Prof. S. Ganesh, currently serving as interim IITK director, has been added to IITK Foundation board as an ex-officio member.

We continued our tradition of a multi-city tour by a delegate of high-level IITK officials – dubbed - IITKarvaan. This year the IITK delegation consisted of Director Prof. Abhay Karandikar, DoIR Prof. Dharendra Katti, Prof. Sandeep Verma, Prof. Ashish Garg, and IITK DF CEO Mr. Kapil Kaul. The objective of the Karvaan once again has been to create massive outreach, brand promotion, university and corporate partnerships, and to promote faculty recruitment. The Karvaan began with a highly successful event in Silicon Valley hosted at the famous Computer History Museum in Mountain View. We also met with numerous accomplished IITK alums in the area and discussed possibility of establishing a formal framework of collaboration between IITK faculty and veteran subject matter experts in IITK alumni community. The Karvaan had additional stops at Houston and New Jersey. This was the first instance of a large meaningful gathering of IITK alum in greater Houston area. We hope that the

event will act as a catalyst for creating a sustainable IITKAA chapter in Houston. In New Jersey, the event was hosted at a beautiful golf club in Clifton and once again the IITK delegation had an opportunity to connect with a number of distinguished alumni about setting up a formal sustainable framework for collaboration. The pictures and videos of events at various cities are captured in Google Drive.

The generosity of our alumni has ensured that IIT Kanpur continues to get much-needed support in terms of resources and time for its growth and expansion. We extend our deep-felt acknowledgment and gratitude to Mr. Deepak Narula for contributing USD 650,000 towards the Gangwal School of Medical Sciences and Technology and joining the League of Founders; Mr. Rajiv Batra for his generosity by donating USD 275,000 towards New Faculty Fellowship, Endowed Chair and Student Award in Cybersecurity, Class of 1970 for selflessly contributing USD 122,000 towards the expansion and upgrade of the gym, whose Foundation Stone laying ceremony was held in February 2023; Mr. Pawan Tewari for his benevolence by contributing USD 380,000 for instituting the Pawan Tewari Chair & Scholarship and USD 500,000 for instituting the Goldman Sachs Endowment towards AI for Social Good, Mrs. Rooma and Mr. Ajay Dubey for generously donating USD 250,000 towards setting up Rooma & Ajay Dubey Healthcare Innovation and Ideation Program (HI). We thank Pullur family for donating USD 610,000 towards The Jay Pullur Neuroscience Initiative which involves instituting The Jay Pullur Non-Invasive Brain Stimulation Laboratory in the Cognitive Science Department, refurbishing PK Kelkar Library and creating an endowment. With your support, IIT Kanpur has been able to institute 7 new scholarships, 5 awards, 4 distinguished lecture series, 1 Young Faculty Fellowship, 1 New Faculty Fellowship, and 5 faculty chairs.

To provide an update on the overall fundraising status to support these initiatives: With the generosity of our benevolent alumni base, we have helped raise over \$8,000,000 (eight million) USD in the calendar year 2022 and over \$6,000,000 (six million) USD in calendar year 2023 (as of 9/30/2023). We express our deep gratitude to all our donors and our progress and success can only continue as we connect with more alumni across the North American continent and create even bigger momentum in the alumni base for the affinity towards the alma mater. We have summarized the fundamental yearly financial information in the newsletter. The detailed information is available at the Foundation website <https://iitkfoundation.org>. Like previous year, we have initiated a complete financial audit with an external firm to ensure that we follow all necessary processes and that our financial operations are in order in the eyes of the Internal Revenue Service. The audit process for FY-22 should complete in the next few months.

I must acknowledge the existing chapter leaders across the country who played an instrumental role in making the IIT Karvaan successful – Jitesh Jain, Shloke Hajela, Namita Maunder, Dhruv Singh, Swati Saxena from Silicon Valley; Ankur Rastogi from Houston; Saurabh Srivastava, Ram Misra, and Ratan Bajpai from New Jersey. Our quest for developing strong IITK local chapters around the country is continued. The chapters are the key enablers of keeping the local alumni base engaged through a variety of activities and strengthen the common bond for our alma mater. I am intending to appoint a dedicated board officer whose charter will be to identify and implement the processes that will facilitate this objective. I also ask the broader alumni for ideas that the foundation can pursue to deepen the engagement with alumni and help raise the prospects for IIT Kanpur.

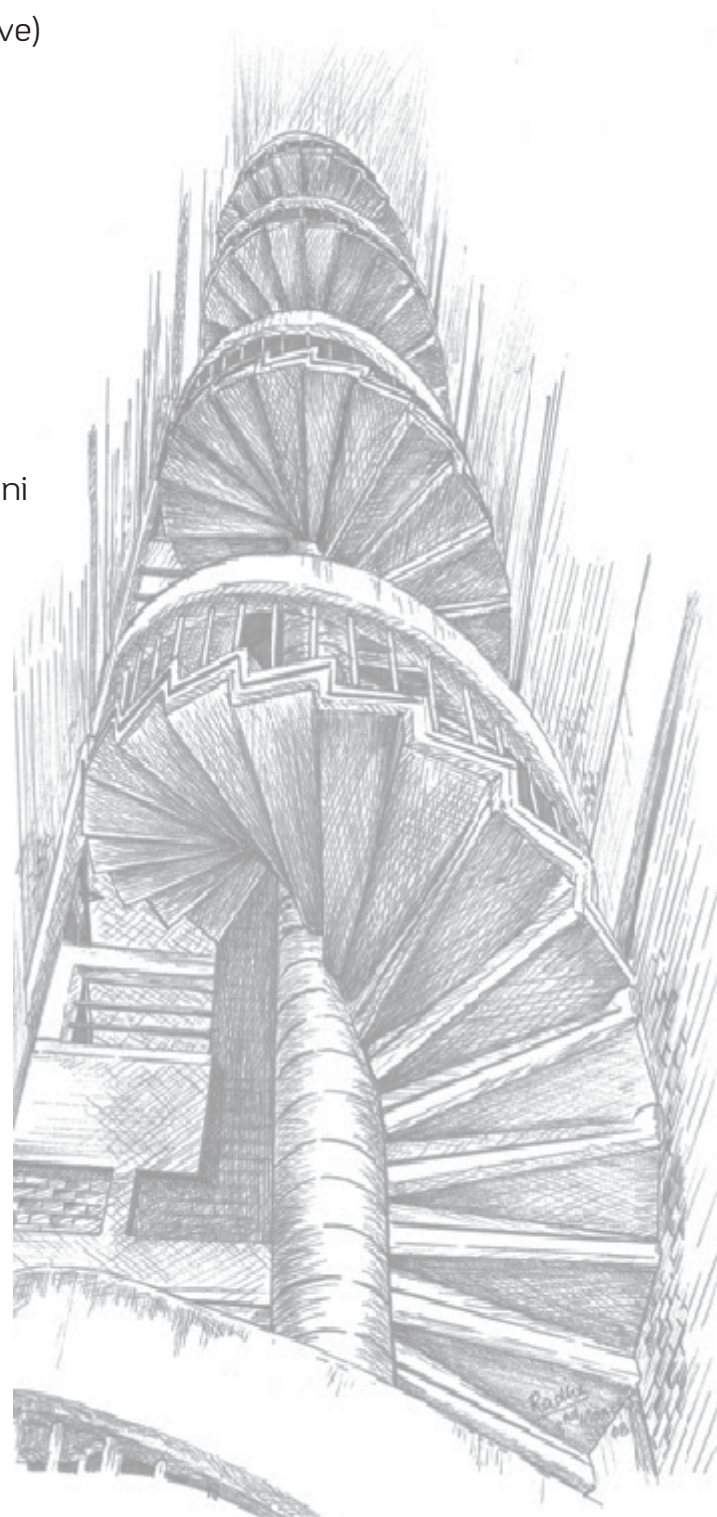

## **Chapter Outreach**

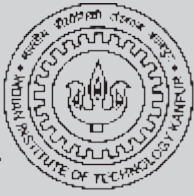

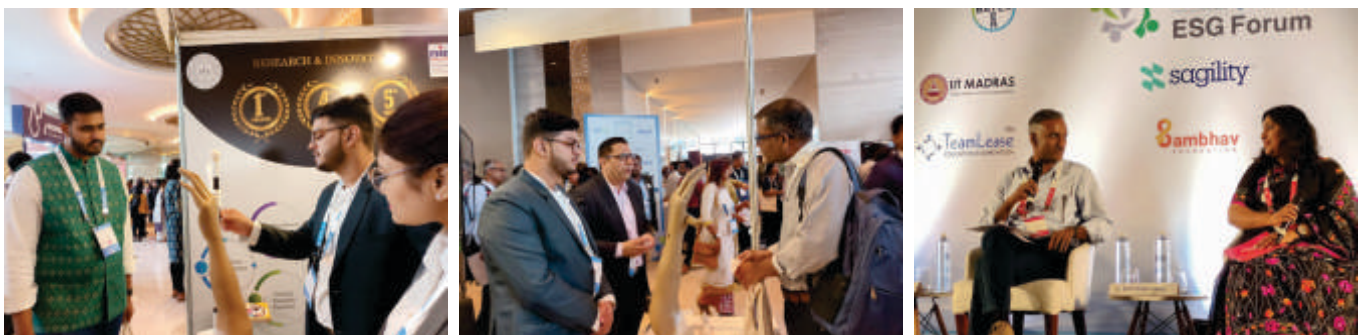
# India CSR Summit 2023
